## **I. Introduction**

1. The Ad Hoc Committee on the Elaboration of a Convention against Transnational Organized Crime was established by the General Assembly in its resolution 53/111 of 9 December 1998.
2. In its resolution 54/126 of 17 December 1999, the General Assembly requested the Ad Hoc Committee to continue its work, in accordance with resolutions 53/111 and 53/114 of 9 December 1998, and to intensify its work in order to complete it in 2000.

## **II. Organization of the session**

### **A. Opening of the session**

3. The Ad Hoc Committee on the Elaboration of a Convention against Transnational Organized Crime held its ninth session in Vienna from 5 to 16 June 2000. The Ad Hoc Committee held 18 meetings.
4. At its eighth session, held in Vienna from 21 February to 3 March 2000, the Ad Hoc Committee had decided to consider at its ninth session articles 2, 2 *bis* (subpara. (a) only), 4 *bis*, 9, 10, 10 *bis*, 14, 14 *bis*, 15 and 16 of the revised draft United Nations Convention against Transnational Organized Crime, as well as to continue its second reading of the draft additional international legal instrument against trafficking in persons, especially women and children.
5. The representative of Guatemala, speaking on behalf of the Group of Latin American and Caribbean States, stated that, at the Tenth United Nations Congress on the Prevention of Crime and the Treatment of Offenders<sup>1</sup> and, more specifically, in the Vienna Declaration on Crime and Justice: Meeting the Challenges of the Twenty-First Century,<sup>2</sup> the participating States had declared that they would accord high priority to the completion of the negotiation of the Convention and its Protocols. The members of the Group wished to reiterate their commitment to achieving that goal. On several occasions, the Group had expressed the view that the vigorous pace of the negotiations should not affect the capacity and willingness of all States to participate in those important discussions on an equal basis. The members of the Group therefore approached the process with a flexible and constructive attitude, considering that the primary objective was to conclude universal instruments that met the concerns of the international community. Finally, the Group was taking a positive attitude towards the possibility of seeking to conclude the negotiation of the Convention at the tenth session of the Ad Hoc Committee.

### **B. Attendance**

6. The ninth session of the Ad Hoc Committee was attended by representatives of 116 States. Also attending the ninth session were observers for organizations of the United Nations system, institutes of the United Nations Crime Prevention and Criminal Justice Programme network, intergovernmental organizations and non-governmental organizations. A list of participants is contained in annex I to the present report.

### **C. Adoption of the agenda and organization of work**

7. At its 137th meeting, on 5 June 2000, the Ad Hoc Committee adopted the following agenda for its ninth session:

1. Opening of the ninth session of the Ad Hoc Committee.
2. Adoption of the agenda and organization of work.
3. Consideration of the additional international legal instrument against trafficking in persons, especially women and children.
4. Consideration of the revised draft United Nations Convention against Transnational Organized Crime, with particular emphasis on articles 2, 2 *bis* (subparagraph (a) only), 4 *bis*, 9, 10, 10 *bis*, 14, 14 *bis*, 15 and 16.
5. Adoption of the report of the Ad Hoc Committee on its ninth session.

### **D. Documentation**

8. At its ninth session, the Ad Hoc Committee had before it, in addition to the documents prepared by the Secretariat, documents containing proposals and contributions submitted by the Governments of Argentina, Azerbaijan, Belgium, Cameroon, Canada, China, Colombia, Egypt, Germany, the Holy See, Italy, the Libyan Arab Jamahiriya, Mexico, Morocco, the Netherlands, Peru, the Philippines, Spain, the Syrian Arab Republic, Thailand and the United States of America, and by the European Community. A list of documents is contained in annex II to the present report.

## **III. Discussion on the additional international legal instrument against trafficking in persons, especially women and children**

9. At its 137th-146th meetings, the Ad Hoc Committee discussed the additional legal instrument against trafficking in persons, especially women and children. It based its work on the revised draft Protocol to Prevent, Suppress and Punish Trafficking in Persons, Especially Women and Children, supplementing the United Nations Convention against Transnational Organized Crime (A/AC.254/4/Add.3/Rev.6) and on proposals and contributions submitted by Governments (A/AC.254/5/Add.25, A/AC.254/L.194, A/AC.254/L.196, A/AC.254/L.201 and A/AC.254/L.202). The Ad Hoc Committee also had before it proposals submitted by the European Community (A/AC.254/L.197) and by an informal working group at the request of the Chairperson (A/AC.254/L.205). Further, the Ad Hoc Committee had before it proposals submitted by the Chairperson (A/AC.254/L.206) and by the Secretariat at the request of the Chairperson (A/AC.254/L.204).

10. The representative of Portugal, speaking on behalf of the States members of the European Union that are Members of the United Nations, informed the Ad Hoc Committee that the representative of the European Commission had been mandated by the Council of the European Union to negotiate on behalf of 12 of the States members of the European Union articles 5, 6 (para. 3), 8 and 9 of the draft Protocol. The Chairman stated that the Ad Hoc Committee would take note of that statement on the understanding that the mandate would not affect the observer status of the European Commission.

11. At its ninth session, the Ad Hoc Committee continued its second reading of the draft Protocol. The new version of the articles of the draft Protocol discussed at the ninth session

of the Ad Hoc Committee was issued in document A/AC.254/L.211/Add.2. The progress achieved in negotiating the draft Protocol by the Ad Hoc Committee at its ninth session will be reflected in a new version of the draft Protocol.<sup>3</sup>

#### **IV. Discussion on the revised draft United Nations Convention against Transnational Organized Crime, with particular emphasis on articles 2, 2 bis (subparagraph (a) only), 4 bis, 9, 10, 10 bis, 14, 14 bis, 15 and 16**

12. At its 147th-154th meetings, the Ad Hoc Committee discussed articles 2, 2 *bis* (subpara. (a) only), 4 *bis*, 9 and paragraphs 1-10 of article 10 of the draft Convention. Because of lack of time, paragraphs 11-15 of article 10 and articles 10 *bis*, 14, 14 *bis*, 15 and 16 of the draft Convention were not discussed and discussion of them was therefore deferred to the tenth session of the Ad Hoc Committee. The Ad Hoc Committee based its work on the revised draft United Nations Convention against Transnational Organized Crime (A/AC.254/4/Rev.8) and on proposals and contributions submitted by Governments (A/AC.254/5/Add.20, A/AC.254/5/Add.23, A/AC.254/L.199, A/AC.254/L.203, A/AC.254/L.210, A/AC.254/L.212, A/AC.254/L.213 and A/AC.254/L.214). The Ad Hoc Committee, continued the process of reaching agreement on the final text in accordance with the relevant recommendation of its Chairman. The Ad Hoc Committee approved paragraphs 1-10 of article 10 of the draft Convention. The progress achieved at the ninth session will be reflected in a new version of the draft Convention.<sup>4</sup>

13. The representative of Thailand presented the report of the Asia-Pacific Ministerial Seminar on Building Capacities for Fighting Transnational Organized Crime, held in Bangkok on 20 and 21 March 2000. Representatives of 20 countries had attended the seminar. The participants had issued a joint ministerial statement in which they had declared the firm political will of countries in the region to use all possible measures to combat transnational crime and the determination of those countries to build and strengthen national policies and to enhance regional cooperation. They had also recognized the need for financial and technical assistance as an important factor in determining effective implementation and recognized an immediate need to combat corruption, welcoming the possible development of another international instrument. They had further declared firm support for the work of the Ad Hoc Committee in finalizing the Draft Convention and its Protocols. The representative of Thailand also informed the Ad Hoc Committee of the Association of South-East Asian Nations (ASEAN) Ad Hoc High-Level Experts Meeting on the draft Convention, held in Bangkok from 22 to 24 May 2000. The participants at that meeting had expressed their intention to continue to be involved in and to contribute to the process of negotiation in a constructive manner. They had expressed their full support for the proposal of Singapore regarding article 2 of the draft Convention on the scope of application and had discussed the related issue of mobilization of financial and technical assistance, which was deemed to be a significant factor for a successful convention. All delegations of ASEAN member States were aware of the urgent need to conclude the Convention and its Protocols by the end of 2000, as mandated by the General Assembly. However, that should be done in a way that would make it possible to meet the concerns of all States in a reasonable manner.

14. The Chairman commended the Government of Thailand for organizing and hosting the Ministerial Seminar and for the commitment that that initiative had demonstrated.

15. The representative of Portugal, speaking on behalf of the States members of the European Union that are Members of the United Nations, informed the Ad Hoc Committee that the representative of the European Commission had been mandated by the Council of the European Union to negotiate on behalf of all the States members of the European Union some aspects of article 4 *bis* of the draft Convention. The Chairman stated that the Ad Hoc Committee would take note of that statement on the understanding that the mandate would not affect the observer status of the European Commission.

## V. Informal consultations

16. At its fourth session, the Ad Hoc Committee had decided that, in future, informal consultations should be organized in order to facilitate the implementation of its mandate.

17. At its eighth session, the Ad Hoc Committee had decided to devote the informal consultations to be held during its ninth session, from 6 to 9 June 2000, to the consideration of articles 19-30 of the draft Convention, in preparation for the finalization of those articles by the Ad Hoc Committee at its tenth session. Also at its eighth session, the Ad Hoc Committee had decided to devote the informal consultations to be held from 13 to 15 June 2000 to the consideration of the additional international legal instrument against the illegal trafficking in and transporting of migrants. The documents before the Ad Hoc Committee at the informal consultations held during its ninth session were A/AC.254/4/Rev.8, A/AC.254/4/Add.1/Rev.5, A/AC.254/5/Add.23, A/AC.254/5/Add.24, A/AC.254/L.195, A/AC.254/L.198, A/AC.254/L.200, A/AC.254/L.208, A/AC.254/L.209 and A/AC.254/CRP.25.

18. The recommendations of the informal consultations were submitted to the Ad Hoc Committee by their Chairpersons (A/AC.254/L.207 and Add.1/Rev.1 and A/AC.254/L.215 and Add.1).

## VI. Adoption of the report of the Ad Hoc Committee on its ninth session

19. At its 154th meeting, on 16 June 2000, the Ad Hoc Committee adopted the report on its ninth session (A/AC.254/L.211).

20. At the same meeting, the Ad Hoc Committee approved the provisional agenda and proposed organization of work for its tenth session, to be held in Vienna from 17 to 28 July 2000 (A/AC.254/L.211/Add.1).<sup>5</sup>

21. In approving the provisional agenda and proposed organization of work for its tenth session, the Ad Hoc Committee decided that its tenth session would be devoted to the finalization and approval of the draft Convention for submission to the General Assembly at its fifty-fifth session for adoption in accordance with Assembly resolution 54/126.

22. The Ad Hoc Committee also decided that it would hold its eleventh session in October 2000 and that it would devote that session to the consideration of the three additional international legal instruments, in accordance with General Assembly resolutions 53/111 and 54/126.

23. The Chairman requested all regional groups to appoint representatives to form a group that would be asked to ensure consistency of the text of the draft Convention in all official languages of the United Nations at the tenth session of the Ad Hoc Committee.

24. The Chairman requested the Secretariat to prepare a document outlining the structure of the official records of the negotiations (the *travaux préparatoires*) and compiling therein all notes intended for the official records to which the Ad Hoc Committee had already agreed and which at present appeared as footnotes in the text of the draft Convention.

25. The representative of Slovenia informed the Ad Hoc Committee that the Group of Eastern European States had decided to appoint the representatives of the Russian Federation and Slovakia to the group mentioned in paragraph 23 above.
